The gravel fill used within the CMP meets NHDOT 304.4 sieve size standards. For structures in uplands, the exterior of the CMP is padded with either 8" of flowable fill or 10" of NHDOT 304.4 mix. For structures in wetlands, we don't put any material around the outside of the CMP.
