**SUBMISSION OF NOMINATIONS OF THE NATIONAL ASSOCIATION
OF REGULATORY UTILITY COMMISSIONERS**

The National Association of Regulatory Utility Commissioners (“NARUC”) welcomes the Federal Energy Regulatory Commission (“FERC” or “Commission”) order establishing the *Federal and State Current Issues Collaborative* (“*Collaborative*”).¹ In response to that Order, NARUC respectfully submits the nominees listed below for consideration.
