Subject: DOT crossing updates

Commissioner Sheehan,

Just wanted to give you some updates on the OHRV crossings/connectors before your meeting tomorrow to review the mapping/permit program that DOS put together. I will not be at the meeting tomorrow;, I am out of state at a conference for the majority of this week.

The majority of permits have been put into the ArcGIS program for the OHRV crossings, etc. Once you folks have all agreed that the format and information looks good we will finish uploading the rest of the data. We have only put in Approved permits so far. I will try to have the applications from Colebrook put in this afternoon so you can review what it looks like in the data program for permits that are in process. The On-Highway Applications for the Town of Colebrook were delivered to District 1 last Thursday. I believe the Town of Colebrook sent their letter directly to you instead of to us for the permit application

We had 3 locations paved last Friday. 2 in Berlin and 1 in Milan. The late winter and cool and wet spring has affected the paving companies being able to get started on projects up north. Photos of the Berlin sites are attached. We are doing site visits with the paving company at the other Coos locations next Tuesday, June 11.

On May 21st we requested DOT District 1 revoke the On-Highway Permit for Jimtown Road in Gorham; permit 01-WOHC035-15. There was no connection to the OHRV trail network from this section of highway. Earlier today we also requested that the permit for Lost Nation Road in Northumberland, permit 01-WOHC07-13, be revoked. The Town closed a Town Road section to OHRV use and as such, there is no OHRV connection along this highway section.

We are finishing the final maps for the existing Off-Highway Connector Applications in Coos County and anticipate that information being to Phil B by the end of this month.

The Department of Justice is still reviewing the draft Use & Occupancy Agreement that was sent to us. The DOT and DNCR attorneys had hoped to have their comments back to us by the end of May, however they have told us that they have been busy with some other projects but plan to get the document back to us with comments shortly. They did comment to us that it appeared to be a redundant process to have a U&O when there is a permit, however we are waiting to get their comments back so we can review further with you.
