Senator Starr's office has received quite a few calls from Colebrook businesses and residents about a proposed ATV crossing on US Route 3/NH Route 145 in Colebrook. Based on the perspective of those calling from Colebrook, the crossing has been in review for a month and a half since a public meeting was held on the trail. Many of those calling hoped to have the crossing's approval by July 4<sup>th</sup>.

I reached out to NHDOT's Mr. Beaulieu for an update on the matter. Please see the e-mails below. NHDOT has collected information from DNCR, and will be reaching out for some more information soon.
