Thanks for the info. From my DOT perspective, I think I need some sort of a plan that is going to show how the access point on NH-145 will be built. There is likely some work that will also be needed to cut the ledge slope back to gain sight distance that should be shown as well. The only reason I am asking for this one is the location of the existing driveway and property line as well as the grades. I am having a hard time visualizing how the trail will be kept separate from the driveway that currently exists. Let me know what you think.

Phil, Gary;

Just wanted to follow up with you about the Rte 3 and Rte 145 permit applications we met on 2 weeks ago.

The Town of Colebrook agrees to open the end of Hughes Road for OHRV use. The owner of Grampy's has also agreed to have the OHRV trail cross his property to get to Hughes Road. We would be looking for approval to use Rte 3 from Hughes Road to the gravel road on the west side of Rte 3. This would eliminate 2/3 of the use requested for Route 3. We are now asking for Hughes Road north, approximately 200'.

On Route 145 the landowner who is going to allow the new trail on his property does not wish to share his driveway or to move his driveway. He wants the trail at the southern property line, where he originally gave permission for it to be located. The abutter to the south, Mr. Mullen, has also been approached the club and our office to inquire about using a portion of his property again and he says it is closed. Our request for Rte 145 would remain as submitted.
