Please find attached several maps as well as the contractor quote for the NEW proposed ATV trail

The OLD trail went behind the Buck Rub and came off of HILL RD. (SOUTH OF THE BUCK RUB) crossing Rt 3 to THE TARNS RD. this crossing has been closed.

The new trail is on the NORTH side of the Buck Rub and CROSSES RT 3 from SPOONER

RD TO 29 HIDDEN ACRES RD (which is the BUCK RUB'S HIDDEN ACRES CAMPGROUND) OR the second crossing; CROSSES RT 3 FROM 2277 N MAIN ST. (WHICH IS BUCK RUB'S OFFICE & ALSO THE NEIGHBORING PROPERTY TO THE BUCK RUB PUB AND LODGE) TO THE CAMPGROUND AS WELL.

The trail then goes through the campground via the road into campground and existing snowmobile trail (State Trail #142) This is where the contractor noted the 2765 feet of gravel and cobblestone. The trail then follows onto The Fitch Property (Which is where the new trail needs to be cut and graveled, the 1600 feet the contractor noted in the quote).

I have marked the maps and color coded them to try and show you the detail.
