From mile post C0.58 in Concord to mile post C21.91 (Silver Lake Road) in Tilton, Vermont Rail System's (VRS) New England Southern Railroad (NEGS) wishes to maintain the corridor for winter railroad operations. No snowmobiles will be allowed to utilize this section of the railroad corridor. Coordination by DNCR to all entities that use this section will be required to spread the word and help prevent trespassers and the associated safety concerns of utilizing an active track.

The Plymouth & Lincoln RR has not shut down for the winter. We would like your assistance with Fish & Game to enforce the "trespassing" laws and keep the snowmobilers off before the opening date. Temporary bridge protection and repairs to the planking protection can be completed on the bridges now after coordinating with the Plymouth & Lincoln Railroad. The red "open" date signs need to have the correct dates placed on them, and this work can be done at any time. Note bridge C#22.05 Tilton/Belmont truss will have all the ties replaced in the summer 2021. Included in this work will be the permanent removal of the upstream sidewalk per an agreement with local enforcement, railroad operator and FRA to help discourage trespassers (swimmers jumping from the bridge).
