Ok thank you Chris.

After internal consideration, the DOT concurs with the Department of Safety regarding the use of approximately 900 feet of US-3 as an OHRV on-highway connector, as well as the use of the existing snowmobile trail that parallels US-3 for approximately 650 feet as an OHRV off-highway connector. The purpose of this proposal is so that OHRVs can gain access to the MOMs store for the Grand Opening over this upcoming weekend. This approval is based on the following conditions:

General Conditions:

 \cdot Approval is limited to Friday 10/12/18 to Sunday 10/14/18. This approval expires $\frac{1}{2}$ hour after sunset on Sunday 10/14/18. Any future use of areas outside of the currently permitted trail system shall follow the permitting approval process outlined in NH Law and State Policies;

· No loading or unloading of OHRVs shall occur within the highway ROW;

 \cdot No motor vehicles, trailers or any catering or servicing equipment of any kind shall be parked within the highway right-of-way (ROW);

· OHRVs shall not have studded tires or tracks;

 \cdot Larry Meservey / MOMs shall be responsible for repairing any damage to the highway infrastructure that may occur as a result of this approval.

Oh-highway Connector:

· OHRVs must use paved travel lanes;

 \cdot OHRVs shall follow the rules of the road, including traveling in the direction of traffic, traveling in single file, obeying regulatory signage, and not traveling at speeds greater than the posted speed limit.

Off-highway Connector:

• Trail signs reading "STOP" shall be installed and maintained on the trail at or near the highway shoulder, and a sign warning of the stop ahead shall be installed on the trail at least 100 feet back from the highway.

We would further request that MOMs be held responsible for coordination of a meeting between the DOT and DNCR – Trails Bureau within two weeks following the event to discuss their current and future plans at the facility and associated trail network.

Commissioner Sheehan, Commissioner Cass, Commissioner Barthelmes and Commissioner Quinn;

Larry Meservey, Sr., manager of Motorcycles of Manchester (MOM's) new Groveton location called me on Monday to inform us that they are having a ribbon cutting event on Saturday, at the new Groveton location, and that they need permission to have OHRVs travel beyond the currently permitted section of Rte 3 (in Groveton Village) to reach the new store. The urgency is solely based on having Governor Sununu attending the event and we have been told that he will be riding in a machine from Groveton to the new store site for the ribbon cutting. State Police Color Guard will also be on hand for the event and Councilor Kenney will also be cutting the ribbon with the Governor. However, the area of Rte 3 near this store is not legally open for OHRV travel.

I apologize for the timing of this request, but we just got a call this week about it and we had no other knowledge of the event this weekend. We did review this area of Rte 3 with DOT Dist 1 and Troop F this spring, in anticipation of this business opening up and had been waiting to hear from them about when they planned to be open and how we would need to configure the connector in this area. The store location is within sight of the 30 mph travel zone in the village, however it is physically located in a 50 mph zone of Rte 3. Under the DOT Policy OHRVs cannot operate with traffic in a 50 mph zone and we would need to use the west side of Rte 3 to get from the 30 MPH zone to the store location. There is an existing snowmobile trail along the side of Rte 3 at this location. The future permanent trail would actually leave DOT property onto private lands but that trail has not been built yet. The letter from the Town of Northumberland and minutes of their Select board meeting to support this future permit request is attached.

The ask is can we get an approval for 3 days of use of the full 30 mph speed zone on the north side of Groveton and either the existing snowmobile trail off of the side of Rte 3 or sign and have OHRVs use the shoulder of the 50 mph zone to get to MOM's for this Friday, Saturday and Sunday? We will hold MOM's accountable for any repair work in the DOT ROW from this weekend and will work with them to get sufficient signage erected to designate the route and also to clearly note that it is for 3 days this weekend ONLY. I have been working with DOT Dist 1 Engineer Phil Beaulieu on this over the past 2 days about whether it was feasible. I have left a message for Lt. Prince about it but have not talked with him yet.

I apologize again for having to come to you with this short timeframe and request.
