Good Morning Jo and others -

There obviously continues to be a lot of conversation and confusion about the allowable uses of the Blackmount Trail.

These questions continue to be raised by the Town, and other residents are raising questions as well – both to the Town and to us.

Roger and the District does not have any additional authority to grant any permissions as are being requested below.

The NH Department of Transportation does not have authority to grant permissions as requested. It is our responsibility to convey the requirements of the federal rules that were used to purchase the trail that is owned by the Town.

We have agreed that a meeting to discuss the options that the Town has would be warranted. Potential dates/times for a meeting in the next couple of weeks include: 10/27 from 1-3, 10/28 from 1-3, 11/2 from 1-3, and 11/4 from 9-11 here in Concord at NHDOT headquarters. Please let me know how these dates might work for you.
