Hi Bill.

I know that line was transferred to the Town many years ago (late 90's or early 2000's). I think it may be two parcels though. The Town uses the section north of Town Hall/Bandstand at Rte 116 as an OHRV trail that connects to the Berlin Branch/Ammonoosuc Recreation Trail. And the portion to the south has nothing on it that I am aware of.

I don't believe we have any RTP funds on this portion for projects. We do give the local ATV club State grant funds to maintain this section, but I do not recall any RTP projects.

The corridor north of Rte 116 is snowmobile, OHRV, horse, bike, hiker, etc. I don't believe there are any uses south of 116.
