Thanks for reaching out - happy to coordinate where we can. I'm copying Maggie Machinist, who is the Regional Forester that manages Nash Stream, as well as Clint Savage who is our District Supervisor for Trails. You can work directly with Maggie and Clint to coordinate the project.

On another note, we are in initial discussions with NHF&G to coordinate the reconstruction of a stream crossing on Terrill Pond Rd on the Ct. Lakes Headwaters property to help restore fish passage and floodplain connectivity, as the culvert is undersized and the road keeps washing out every year. My understanding is that DES uses the road to access the dam on Terrill Pond. Hoping DES could partner on this project since we will all benefit from restoring the stream crossing.
