Hi Phil,

Thanks for getting back to me. Just to give you a heads up the club is going to the town to see if they will support opening up Rt. 145 and Rt.3 to keep the process moving. They are trying to have connections in place to open on May 23<sup>rd</sup>.

The club has permission from the landowner just north of Hugh's road to get to Rt. 145. They will be looking to go down 145 to get access to Hugh's Rd. If DoT is going to have concerns about accessing Hugh's Rd from 145 then the club is going to ask the town to support using 145 all the way into town. If you have thoughts on that would you let me know so the club can ask the town for the appropriate section of road.

The crossing at Grampies will no longer be needed at this time for OHRV's. The landowner on west side of Rt.3 has changed their mind and is no longer going to allow access across their property.

The plan for that crossing is to come out of the entrance to the IGA and go north on Rt.3 to another access road that is just north about 500 feet that goes down to the rail bed. The club has permission from both owners on either end of the On Highway Connector.
