Dear Chairman Sykes and House Transportation Committee members,

Here are some documents related to HB 498 and HB 592.

Commissioner Sheehan states that roads will be used by OHRVs "rare cases" and the DOT is working on behalf of "all the citizens of NH." After 6 years of living with "Ride the Wilds," the residents living along the miles of roads opened as OHRV trails in Coos are feeling like 2nd class citizens.

The 10:00 curfew in Gorham was granted for "special" events. The Coos County Sheriff's office is currently trying to change the curfew season-wide to 9:00pm - extending the hours of disturbance for trail abutters, despite their cries for relief.

The 2016 North Country Council trail counts are out of date, but give an idea of the number of OHRVs traveling down roads w/tractor trailers and logging trucks etc. July and August traffic generally surpasses September counts, when school is back in session.
