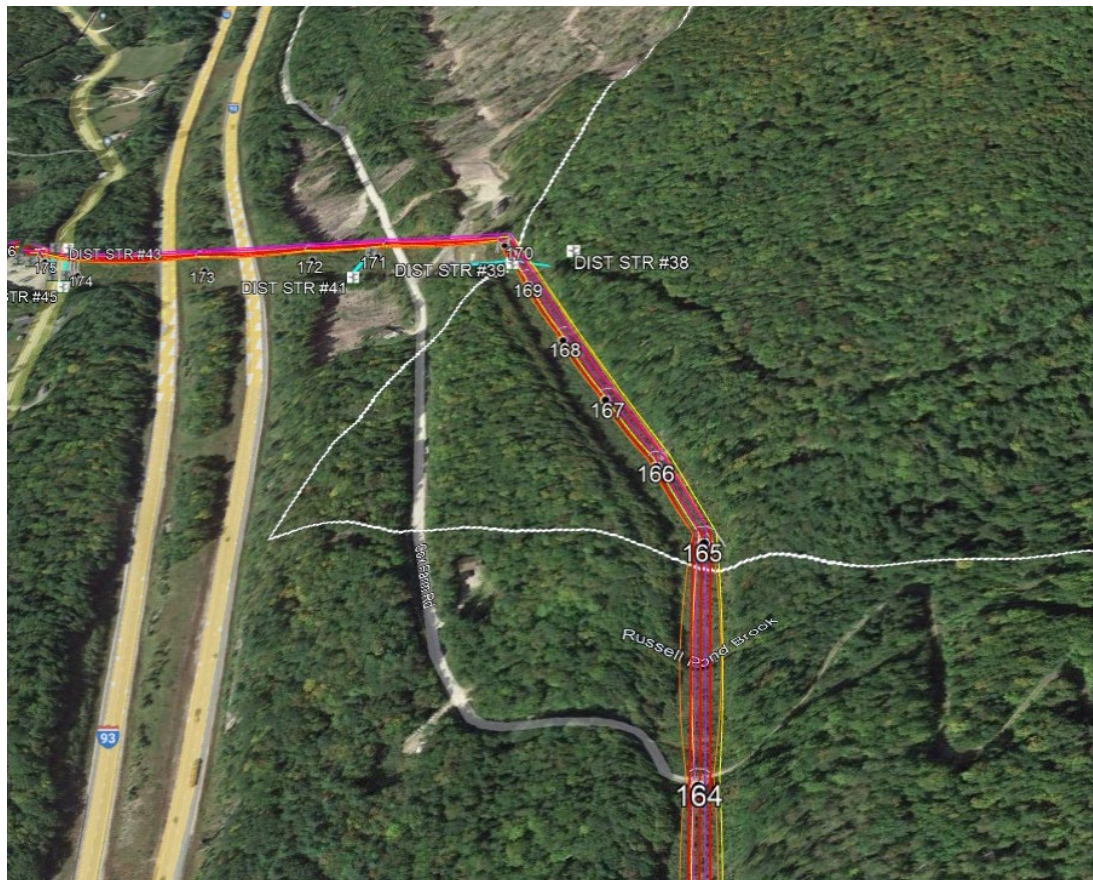

Hi Jeremy,

I wanted to touch base with you about some lingering questions regarding projects X178-1 and S136 that I need answered for the NEPA submission. I sent you a few emails while you were on leave and just wanted to make sure they didn't fall through the cracks – I apologize for the nudge if you're still digging out your inbox. Below are repeat questions from past emails:

- Who is doing the actual implementation of these projects?
- Implementation Timeframe – Will work happen all year or are there seasonal limitations?
- Do you have spatial data for these segments? I'm looking for shapefiles that depict the access, DOT roads, ROW, town boundaries, etc. that might be accessed just for these projects. In addition, shapefiles that depict existing structures, proposed structures, pull pads, work pads, wetland impact, etc.
 - For X178-1, I have the screenshot below – can you send corresponding spatial data specifically for STR 165-170 or those inside WMNF boundary?



- Similarly, for S136, I have a map set from Stantec (see attached) that show the conceptual design. Do you have more current spatial data for this segment?

Again, all these details are required for the NEPA submissions. I'm submitting them as two separate projects since they're located on two separate districts. If it's easier to talk it though, feel free to give me a call.
