They weren't directly relevant to the -1 segment but I wanted to pass them along to you as helpful information to keep in mind for any current or upcoming projects/proposals. Please see the attached maps and comments below.

Sheet 2: Forest boundary shown in wrong location. Mistakenly showing Purchase/Declaration boundary (common issue). Related to this, on all sheets "White Mountain National Forest" label is centered in every sheet and doesn't properly show USA ownership in most cases.
Other sheets: highlighted property monuments near project area to avoid disturbing.
