Eversource had an internal meeting today and we've unfortunately discovered that due to road postings in the April timeframe, we won't be able to perform the proposed drilling work at this time. We won't be able to mobilize our equipment to the laydown area in Easton. We are now targeting the winter window of Q-1 of 2026.
