I saw that Jasmin was going into a meeting at 8:30 this morning to discuss this project and I hadn't seen a response from you yet, so I called Jasmin to give her as much info as I could in advance of her meeting. If the answers I gave her below are incorrect, please feel free to follow up. I answered these based on my recollection of our meetings with Crux discussing this work.

These 5 – 16'x20' landing areas are just for personnel only? Yes, these areas have been strategically selected along the line to deliver personnel safely and to prevent/reduce long hike distances to boring locations.

Will equipment and materials also be flown in at these locations or will those be dropped off at the immediate boring locations? No, it is my understanding that equipment and materials will be delivered via helicopter to boring locations.

Does that mean the helicopter will just land and take off again? Or will the helicopter remain there for the duration of the workday? I did not have an answer for her and we need to follow up.

Jasmin also asked if the same helicopter will be performing the personnel delivery and the equipment and materials delivery, or would there be two separate helicopters working on tandem? I did not have an answer for her and we need to follow up.
