Hey Jasmin! Welcome back! I'm sure you're thrilled about all the changes you missed... I was in the same boat as you last week after coming back from vaca.

This project is an unusual one in that a different agency (the Army Corps) did the consultation with USFWS. This is because our ownership covers only a small part of the total project area. The Corps and the USFWS agreed to avoid tree clearing and trimming from April 15 through October 31 because some of the project area occurs near bat hibernacula.

Do these Geotechnical Investigations involve tree clearing or trimming? If not, you're good to go. If so, I think the Corps (or their designated representative) would have to reach out to the USFWS.

We shouldn't have to worry about the BCS because, as I understand it, this project only involves tree trimming in an existing right-of-way. The BCS does not establish any time-of-year restrictions on this type of activity.

#### Hi Jasmin,

I'm not familiar with this project, but I think I recognize the name as one that's gone through Small Projects Day, correct? I would ask the bio who did the BE. If they consulted saying that the proponent would completely stay out of the active season, they'd need to reconsult if they want to go past April 15. I realize it's only one day, but that's the date we committed to with the Fish and Wildlife Service if we said the project is consistent with the BCS. We can do that reconsultation if we need to.

And FYI, it generally doesn't matter what the state agrees to. Federal agencies are held to a higher standard with Endangered Species Act stuff, plus the agreement we have with the Fish and Wildlife Service allows us to push through a lot of projects easily if we follow the BCS. The tradeoff may be that things like this are a little less flexible. But see what the bio who worked on the project thinks since they'll be way more familiar with the project than me. Or I can do it if you'd prefer, just tell me what district it's on.
