


Hi Jasmin,

Following up on last week's coordination call with you, Marianne, and Brooke. Eversource is planning to transport personnel via helicopter to the Kinsman Notch segment of the X178 line to review/recon the proposed geotechnical investigation locations and helicopter construction scope with the contractor. The flight is scheduled to take place during daylight hours on 8/26 (with rain dates of 8/27 or 8/28). Once the flight dates are finalized, I will follow-up with you with confirmation and a tail number for the aircraft.

Due to the number of personnel and the small helicopter to be used, it is expected that multiple flights will be necessary to transport the group between the ROW landing zone (44.099996,-71.759433) from the pick-up/drop-off location in Campton (43.845806,-71.654208), approximately 18.3 miles per trip. Once the group is transported to the ROW, they will proceed onfoot for the field review. In total, it is anticipated that the helicopter will make 6-10 flights between the pick-up/drop-off and LZ.


