Hey Ridge,

That document I reference, "Z180 NHFG Correspondence Memo updated 10-18-22," is the document that includes Eversource's proposed conservation measures. They begin on the second page under "Eversource proposed the following conservation measures..." I had correspondence with Eversource to correct the initial ones that they submitted, which were not in line with what NHFG was recommending. Sometimes, Eversource creates a BMP document for T&E species that include their proposed conservation measures, so I wanted make sure that what they were proposing matched the basics of our recommendations (for example, corrected date ranges and corrected instructions on how to handle encountering a T&E species). That being said, the bullets listed under that point address what NHFG recommends as permit conditions and includes further details and some additional recommendations. I've attached my email thread with Kurt and Sherrie for context, but feel free to give me a call with any other questions. We've had a changing process lately as we're working with Eversource and going back and forth with ideas on streamlining consultation.

Thanks for making the changes. I think some of my edits were missed. Wood turtle nesting season may extend beyond June 15<sup>th</sup>. It should be considered to be until July 15<sup>th</sup>, and personnel should be made aware of the potential to encounter nesting turtles until then. The point regarding inspecting areas prior to mowing, matting, and/or gravel placement was also left off in the most recent version. Please include this point in addition to my comment about sweeps being conducted immediately prior to work start and equipment movement.

Sorry again for the confusion. For additional information –

Please note that starting at the Huckins Hill Substation, we have updated the structure numbering to start at "1" vs "284" as is currently the case. The old structure numbers are provided on the updated plan set for reference.

There are currently a total of 38 existing transmission structures on the Z-180 circuit – 9 of which are steel. On the latest revision, it was determined that one of the steel structure (294/11) also needs replacement due to design requirements.

So in summary:

- 28 wood structures will be replaced
- 1 wood structure (301) will be removed entirely; and
- 1 steel structure (294/11) will be replaced.

Good afternoon Kat,

I think I can be of assistance. The plan set dated 9/28 is the approved project plan with revisions from the latest site walk. There are 29 remaining wood pole structures to be replaced as originally stated. The poles with smaller work pads have previously been replaced as part of Eversource's Asset Condition Refurbishment (ACP) program and will only be accessed to change out the conductor and shield wire as part of the proposed complete rebuild of the Z80 line.

In addition, existing Structure 301 is being removed and the entire line is being renumbered during the rebuild (as indicated by the red numbers).

In the Z180 Folder, the Z180 NHFG Correspondence Package was the original submittal before the plans were revised. I will remove that document from the folder to eliminate any confusion.

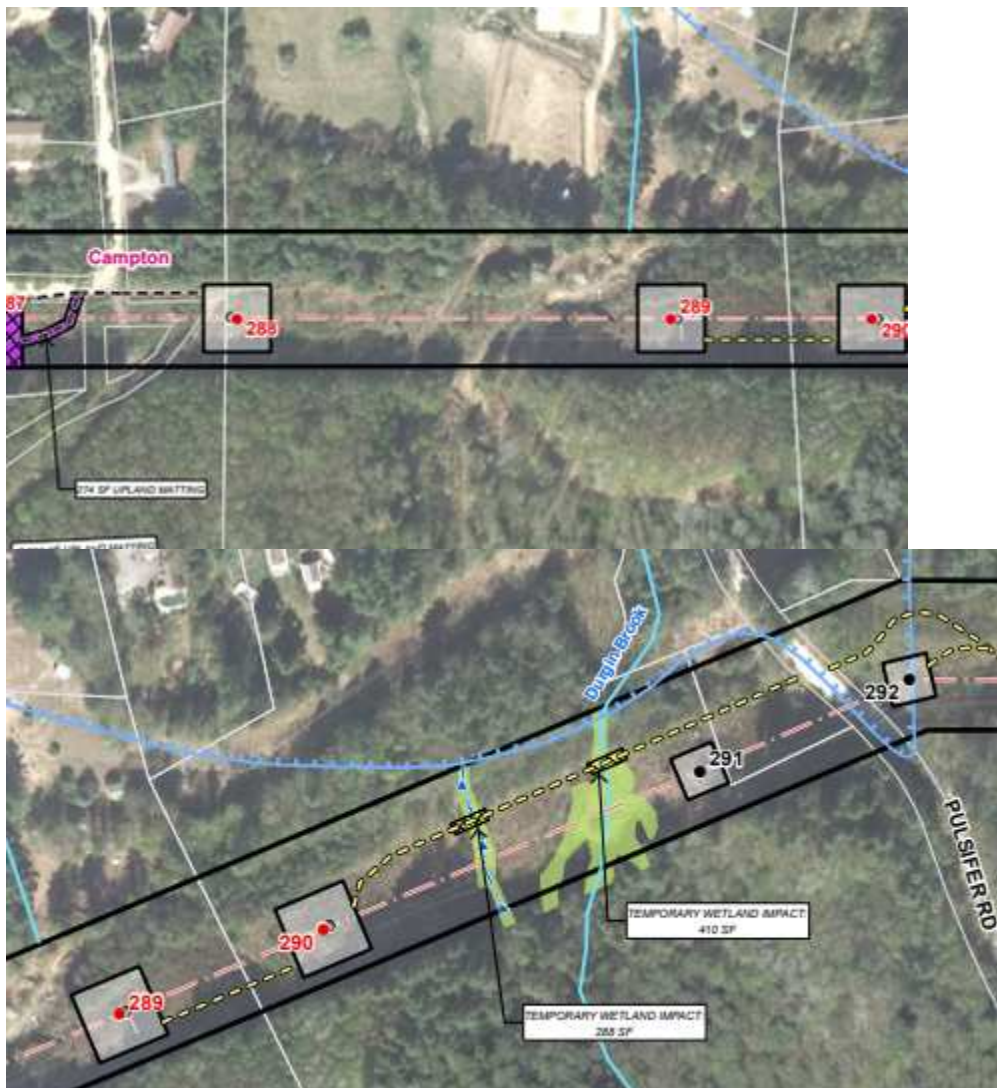

Hi Kat,

We will make sure the next iteration of the plan set shows topographical contours. There is an extremely steep slope between Structures 288 and 289 with some excavation on the slope and is the reason we proposed coming from the north off of Pulsifer Road to access Str 289. It appears there maybe an access with a more moderate approach that goes through the wood line on the west side between Str 288 and 289 that leads to Str 290. Not sure if this access is entirely within our Right of Way. If not we would need land owner permission to utilize this alternative access Route. We'll investigate this. We'll also take some photos of the Durgin Brook Crossing area to allow for a better assessment of the habitat characteristics.

Ok, thanks. I will wait until you send the updated plans to continue review. If tree clearing is proposed on the northern half of the line, the following voluntary conservation measures should be considered for bats:

- Avoid clearing suitable spring staging and fall swarming habitat within a 5-mile radius of known or assumed northern long-eared bat hibernacula during the staging and swarming seasons (April 1 to May 15 and August 15 to November 14, respectively).
- Conduct tree removal activities outside of the northern long-eared bat pup season (June 1 to July 31) and/or the active season (April 1 to October 31). This will minimize impacts to pups at roosts not yet identified.
- Manage forests to ensure a continual supply of snags and other suitable maternity roost trees.

Can the Durgin Brook crossing be avoided completely by using other access?

You are correct in that we will not be traversing the Beebe River/wetland complex area. The target for start of construction is February 2023. Given the location of the Durgin Brook crossing it may be difficult to hold off on access until May 1. If there are alternatives to a Time of Year Restriction at this location, it would be preferable.

FYI – we have recently conducted another field review of the project and have some changes to the access routes and work pad locations. We have also identified a few other areas requiring tree removal/trimming on the ROW edge. I will provide you with an updated plan set once it is available.

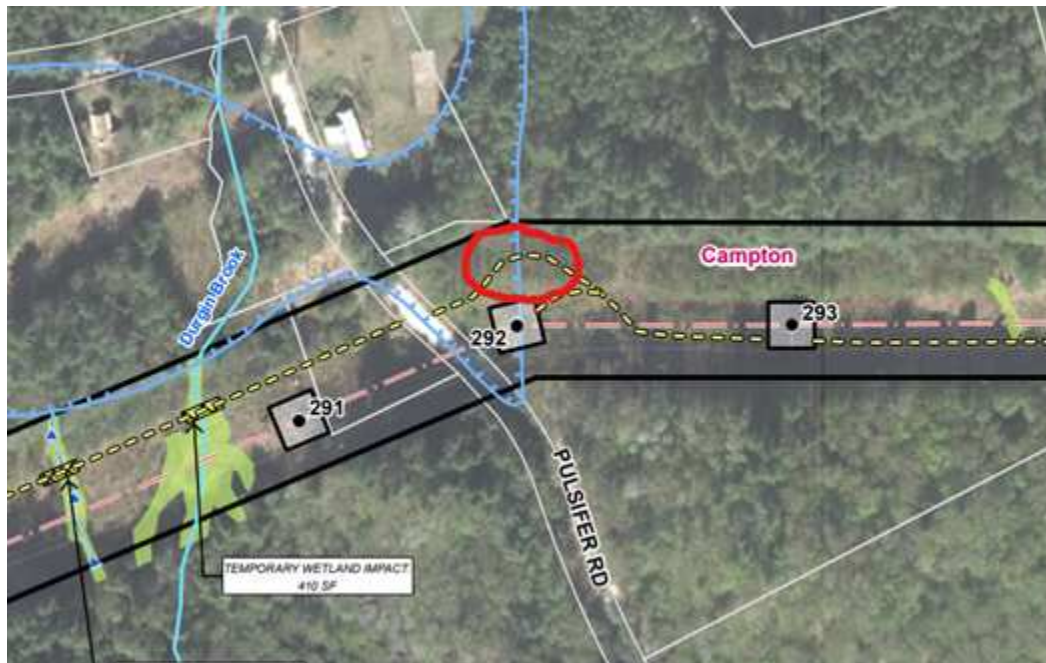

(7) *Description of the proposed action:*

Eversource has identified the need to replace this line due to the age and condition of the twenty nine (29) existing wooden electric transmission line structures resulting from woodpecker damage, insect damage, and pole rot. The existing wooden electric transmission structures will be replaced with new



weathered steel structures, ceramic conductors will be replaced with glass conductors, and optical ground wire (OPGW) will be installed in accordance with current construction methods and materials. Additionally, nine (9) steel structures exist on the line that will be accessed for OPGW installation and reconductoring but will not be replaced. Installation of the new 1272 ACSS conductor on all structures will bring the line up to current design standards

Two (2) structure replacements will occur in Holderness and twenty seven (27) structure replacements will occur in Campton. No vernal pools were found to occur within the ROW. Work areas at each structure will be approximately 100x100 feet centered on the structure to be replaced. All areas in wetlands will be temporarily timber matted and restored following construction activities; timber matting will be removed as soon as possible. Utility Maintenance BMPs will be followed. Oversight monitoring will be at least weekly.

Construction is scheduled to begin in February of 2023 and will extend for an estimated 6 months. Mapping depicting the project location is attached along with relevant .shp and .kmz files showing the work areas.

The NHB DataCheck (NHB22-2179) has identified the project is located within potential or known habitat for the following species:

- Sensitive Species
- Sensitive Species
- Wood Turtle (*Glyptemys insculpta*)

Eversource proposes the following conservation measures to avoid, minimize and/or mitigate potential harm to threatened and endangered species and habitat determined to be critical:

- All contractors will be trained by the project qualified herpetologist in the identification and response protocols for observation of Wood turtles.
- If work is to occur during the turtle nesting season, extending from approximately May 15<sup>th</sup> - July 15<sup>th</sup>, a biologist with turtle experience will be on site daily to check for protected turtles along the ROW in work areas before crews start work for the day.
- Before the start of construction and movement of equipment, searches and sweeps shall be conducted prior to mowing, matting, and/or gravel placement in order to minimize the chance of animals entering an area between the sweep and work.
- In the event a threatened or endangered species is observed on the project site during the term of the permit, the species shall not be disturbed, handled, or harmed in any way prior to consultation with NHFG and implementation of corrective actions recommended by NHFG.
- Site operators shall be allowed to relocate wildlife encountered if discovered within the active work zone and if in direct harm from project activities. Wildlife shall be relocated in close proximity to the capture location but outside of the work zone and in the direction the individual was heading. NHFG shall be contacted immediately if this action occurs.
- In accordance with Eversource's BMP manual for E&S controls, only biodegradable E&S controls (with the exception of silt fence which will be removed post-construction) will be utilized. No nylon, welded plastic or photodegradable E&S controls shall be permitted for use on the project.
- Sedimentation and erosion controls will be installed, monitored and maintained to protect adjacent upland and wetland areas from sedimentation and degradation; disturbed areas will be temporarily and permanently stabilized and seeded with a native seed mix.

- Bridge matting shall be installed with gaps which facilitate travel by turtles, snakes and other wildlife. Gaps should be created roughly every 30’.
- Signage to identify specific locations where there may be a higher likelihood for species to be present, such as wetland crossing areas will be utilized.

Previous work on the Z180 Transmission Line resulted in nine (9) existing wooden structures along the having been replaced with new weathered steel structures. Areas of gravel access and work pads at some of these structure locations were still visible during site walks as vegetation continues to regrow.

*(11) Any habitat features supporting or that could support threatened and endangered species that have been identified;*

**Wood Turtle (*Glyptemys insculpta*):**

Wood turtles are primarily found near forested streams or rivers, an area in which they hibernate during the winter. During the spring and summer, they will leave the water and move to open grasslands and gravel shores for nesting and foraging. Within the project area, the Z180 Transmission Line traverses four intermittent streams, Durgin Brook, Palmer Brook, the Beebe River and various freshwater forested/shrub wetlands and emergent wetlands that can provide potential suitable habitat for turtle nesting. Additionally, the silver maple (*Acer saccharinum*) floodplain along the Pemigewasset River, located east of the project area, provides suitable overwinter habitat. However, there are also a number of steep slope areas throughout the project area where turtles are unlikely to traverse.

*(12) A description of any conservation measures proposed by the applicant to avoid, minimize, or mitigate potential harm to threatened and endangered species and habitat determined to be critical, including but not limited to:*

- All contractors will be trained by the project qualified herpetologist in the identification and response protocols for observation of Wood turtles.
- If work is to occur during the turtle nesting season, extending from approximately May 15th - July 15th, a biologist with turtle experience will be on site daily to check for protected turtles along the ROW in work areas before crews start work for the day.

- Before the start of construction and movement of equipment, searches and sweeps shall be conducted prior to mowing, matting, and/or gravel placement in order to minimize the chance of animals entering an area between the sweep and work.
- In the event a threatened or endangered species is observed on the project site during the term of the permit, the species shall not be disturbed, handled, or harmed in any way prior to consultation with NHFG and implementation of corrective actions recommended by NHFG.
- Site operators shall be allowed to relocate wildlife encountered if discovered within the active work zone and if in direct harm from project activities. Wildlife shall be relocated in close proximity to the capture location but outside of the work zone and in the direction the individual was heading. NHFG shall be contacted immediately if this action occurs.
- In accordance with Eversource's BMP manual for E&S controls, only biodegradable E&S controls (with the exception of silt fence which will be removed post-construction) will be utilized. No nylon, welded plastic or photodegradable E&S controls shall be permitted for use on the project.
- Sedimentation and erosion controls will be installed, monitored and maintained to protect adjacent upland and wetland areas from sedimentation and degradation; disturbed areas will be temporarily and permanently stabilized and seeded with a native seed mix.
- Bridge matting shall be installed with gaps which facilitate travel by turtles, snakes and other wildlife. Gaps should be created roughly every 30'.
- Signage to identify specific locations where there may be a higher likelihood for species to be present, such as wetland crossing areas will be utilized.

Please note that starting at the Huckins Hill Substation, we have updated the structure numbering to start at "1" vs "284" as is currently the case. The old structure numbers are provided on the updated plan set for reference.

There are currently a total of 38 existing transmission structures on the Z-180 circuit – 9 of which are steel. On the latest revision, it was determined that one of the steel structure (294/11) also needs replacement due to design requirements.

So in summary:

- 28 wood structures will be replaced
- 1 wood structure (301) will be removed entirely; and
- 1 steel structure (294/11) will be replaced.

I think I can be of assistance. The plan set dated 9/28 is the approved project plan with revisions from the latest site walk. There are 29 remaining wood pole structures to be replaced as originally stated. The poles with smaller work pads have previously been replaced as part of Eversource's Asset Condition Refurbishment (ACP) program and will only be accessed to change out the conductor and shield wire as part of the proposed complete rebuild of the Z80 line.

In addition, existing Structure 301 is being removed and the entire line is being renumbered during the rebuild (as indicated by the red numbers).

In the Z180 Folder, the Z180 NHFG Correspondence Package was the original submittal before the plans were revised. I will remove that document from the folder to eliminate any confusion.

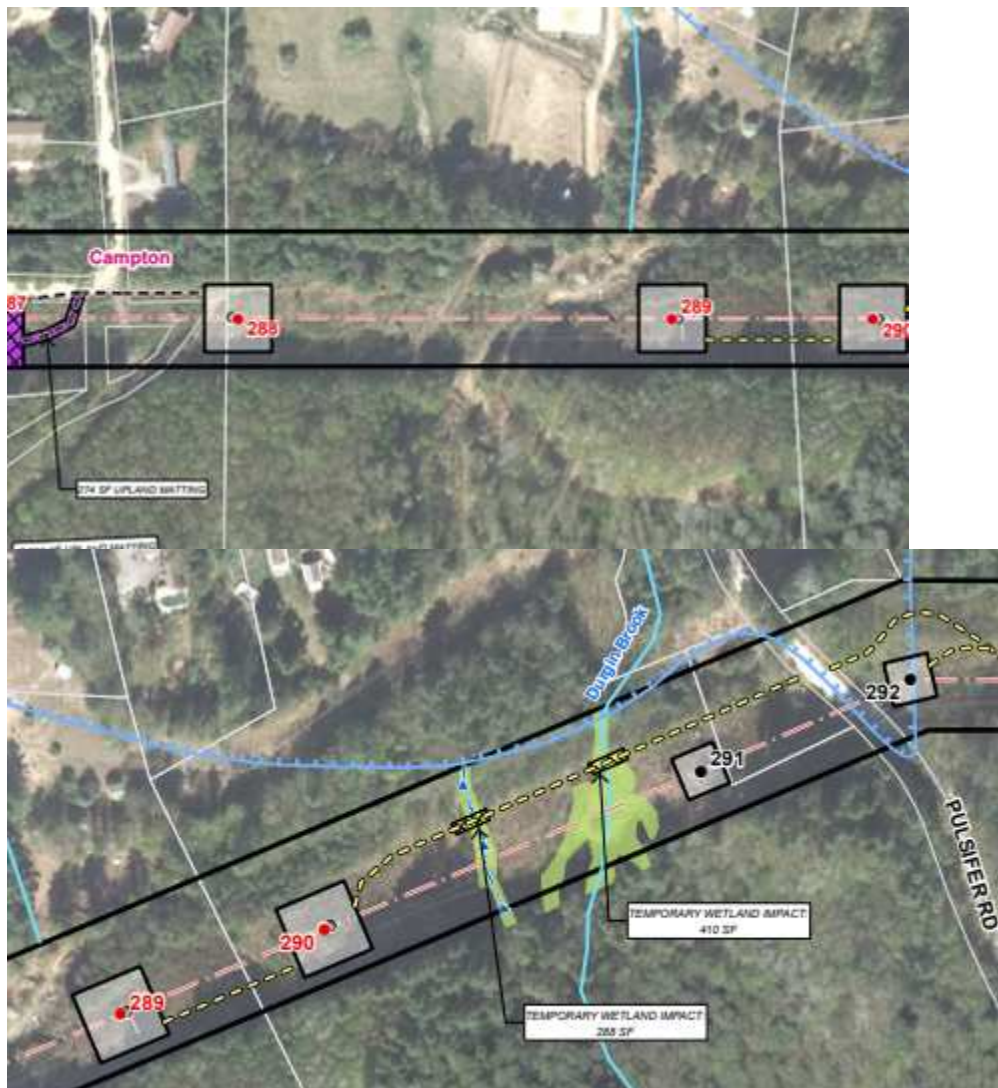

We will make sure the next iteration of the plan set shows topographical contours. There is an extremely steep slope between Structures 288 and 289 with some excavation on the slope and is the reason we proposed coming from the north off of Pulsifer Road to access Str 289. It appears there maybe an access with a more moderate approach that goes through the wood line on the west side between Str 288 and 289 that leads to Str 290. Not sure if this access is entirely within our Right of Way. If not we would need land owner permission to utilize this alternative access Route. We'll investigate this. We'll also take some photos of the Durgin Brook Crossing area to allow for a better assessment of the habitat characteristics.

- Avoid clearing suitable spring staging and fall swarming habitat within a 5-mile radius of known or assumed northern long-eared bat hibernacula during the staging and swarming seasons (April 1 to May 15 and August 15 to November 14, respectively).
- Conduct tree removal activities outside of the northern long-eared bat pup season (June 1 to July 31) and/or the active season (April 1 to October 31). This will minimize impacts to pups at roosts not yet identified.
- Manage forests to ensure a continual supply of snags and other suitable maternity roost trees.

Can the Durgin Brook crossing be avoided completely by using other access?

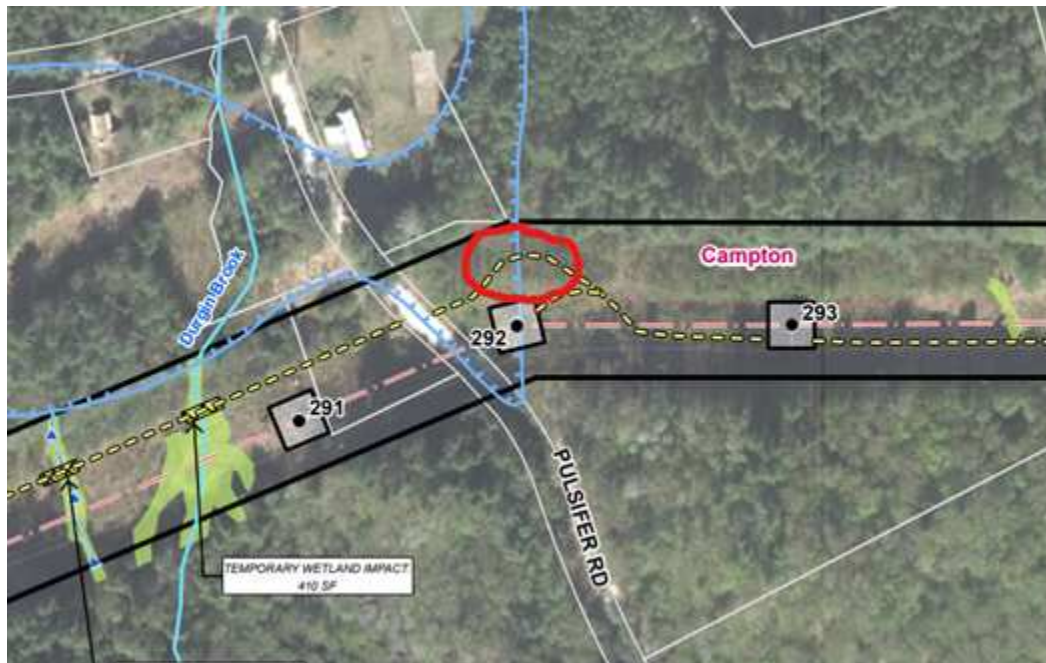

(7) *Description of the proposed action:*

Eversource has identified the need to replace this line due to the age and condition of the twenty nine (29) existing wooden electric transmission line structures resulting from woodpecker damage, insect damage, and pole rot. The existing wooden electric transmission structures will be replaced with new



weathered steel structures, ceramic conductors will be replaced with glass conductors, and optical ground wire (OPGW) will be installed in accordance with current construction methods and materials. Additionally, nine (9) steel structures exist on the line that will be accessed for OPGW installation and reconductoring but will not be replaced. Installation of the new 1272 ACSS conductor on all structures will bring the line up to current design standards

Two (2) structure replacements will occur in Holderness and twenty seven (27) structure replacements will occur in Campton. No vernal pools were found to occur within the ROW. Work areas at each structure will be approximately 100x100 feet centered on the structure to be replaced. All areas in wetlands will be temporarily timber matted and restored following construction activities; timber matting will be removed as soon as possible. Utility Maintenance BMPs will be followed. Oversight monitoring will be at least weekly.

Construction is scheduled to begin in February of 2023 and will extend for an estimated 6 months. Mapping depicting the project location is attached along with relevant .shp and .kmz files showing the work areas.

The NHB DataCheck (NHB22-2179) has identified the project is located within potential or known habitat for the following species:

- Before the start of construction and movement of equipment, searches and sweeps shall be conducted prior to mowing, matting, and/or gravel placement in order to minimize the chance of animals entering an area between the sweep and work.
- In the event a threatened or endangered species is observed on the project site during the term of the permit, the species shall not be disturbed, handled, or harmed in any way prior to consultation with NHFG and implementation of corrective actions recommended by NHFG.
- Site operators shall be allowed to relocate wildlife encountered if discovered within the active work zone and if in direct harm from project activities. Wildlife shall be relocated in close proximity to the capture location but outside of the work zone and in the direction the individual was heading. NHFG shall be contacted immediately if this action occurs.
- In accordance with Eversource's BMP manual for E&S controls, only biodegradable E&S controls (with the exception of silt fence which will be removed post-construction) will be utilized. No nylon, welded plastic or photodegradable E&S controls shall be permitted for use on the project.
- Sedimentation and erosion controls will be installed, monitored and maintained to protect adjacent upland and wetland areas from sedimentation and degradation; disturbed areas will be temporarily and permanently stabilized and seeded with a native seed mix.

- Bridge matting shall be installed with gaps which facilitate travel by turtles, snakes and other wildlife. Gaps should be created roughly every 30’.
- Signage to identify specific locations where there may be a higher likelihood for species to be present, such as wetland crossing areas will be utilized.

The project includes managed right-of-way within the Z180 Transmission Line corridor in the Towns of Campton and Holderness. Project plans depicting the parcel boundaries and work areas are provided in Attachment C.

Previous work on the Z180 Transmission Line resulted in nine (9) existing wooden structures along the having been replaced with new weathered steel structures. Areas of gravel access and work pads at some of these structure locations were still visible during site walks as vegetation continues to regrow.

*(11) Any habitat features supporting or that could support threatened and endangered species that have been identified;*

**Wood Turtle (*Glyptemys insculpta*):**

Wood turtles are primarily found near forested streams or rivers, an area in which they hibernate during the winter. During the spring and summer, they will leave the water and move to open grasslands and gravel shores for nesting and foraging. Within the project area, the Z180 Transmission Line traverses four intermittent streams, Durgin Brook, Palmer Brook, the Beebe River and various freshwater forested/shrub wetlands and emergent wetlands that can provide potential suitable habitat for turtle nesting. Additionally, the silver maple (*Acer saccharinum*) floodplain along the Pemigewasset River, located east of the project area, provides suitable overwinter habitat. However, there are also a number of steep slope areas throughout the project area where turtles are unlikely to traverse.
